#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Methow Valley Irrigation District from January 1, 2010 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

#### ABOUT THE DISTRICT

The Methow Valley Irrigation District was formed in 1901 to provide irrigation water to the Methow Valley. The District serves approximately 280 landowners. An elected, three-member Board of Directors governs the District. In fiscal year 2012, the District had three employees and generated approximately \$214,000, \$168,000 and \$190,000 in revenue in 2010, 2011 and 2012, respectively. The District's primary revenue source is from property assessments.
