ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the City of Brewster from January 1, 2011 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the City. We also determined whether the City complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

• Payroll disbursements

• Automated clearinghouse transfers

RESULTS

In the areas we examined, the City's internal controls were adequate to safeguard public assets. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE CITY

The City of Brewster, located in Okanogan County, was incorporated in 1910 and has a population of approximately 2,200 citizens. The City is administered by a mayor-council form of government with five elected Council Members and an independently elected Mayor. The City operated on annual budgets of \$2.7 million in 2011 and \$3.3 million in 2012. Its 19 full-time employees provide an array of services including water, sewer, garbage, police, fire, Municipal Court, public improvements, planning and economic development.

We audit the City every two years. We have issued two findings in the past seven years as well as a Fraud Investigation Report in 2012. We issued findings in both 2007 and 2010 for weaknesses in internal controls over financial activities and reporting. The findings have been resolved.
