# Prosser School District No. 116 Benton County April 30, 2014

### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Prosser School District No. 116 from September 1, 2010 through August 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Open public meeting minutes
- Payroll
- Vendor payments
- Student enrollment reporting
- Teacher education and experience (staff mix) reporting
- Student transportation reporting

#### RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### ABOUT THE DISTRICT

Prosser School District No. 116 provides educational services to approximately 2,800 students in kindergarten through 12th grade in Benton County. The District operates one high school, one alternative school, a middle school and three elementary schools.

An elected, five-member Board of Directors administers the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 400 employees. The District had total revenue of approximately \$30.5 million, \$29.7 million and \$28.3 million in fiscal years 2011, 2012 and 2013, respectively.

### **AUDIT HISTORY**

We audit the District once every three years. The past three audits were two-year audits. In the last four audits, the District received one finding related to inventory misappropriation. This finding has been resolved. No findings have been reported since 2006.
