ABOUT THE AUDIT

This report contains the results of our independent accountability audit of North Beach School District No. 64 from September 1, 2010 through August 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Open Public Meetings Act
- General revenues
- General expenditures
- Financial condition
- Apportionment staff mix
- Apportionment enrollment

- Apportionment transportation
- Associated Student Body
- Cash receipting internal controls
- Accounts payable internal controls
- Payroll internal controls

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE DISTRICT

North Beach School District No. 64 provides educational services to approximately 650 students in preschool through 12th grade in Grays Harbor County. The District has four schools, two elementary, one junior high and one high school.

The District's five-member Board of Directors is the primary policy-making body, exercising budgetary and financial control for the District. Members are elected to staggered, four-year terms. The Superintendents and staff administer day-to-day operations and carry out decisions made by the Board. The District operates on an \$8.2 million annual budget. The District has 43 certificated and 31 classified staff.
