ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the West Thurston Fire Authority from January 1, 2013 through December 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the Authority. We also determined whether the Authority complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Cash receipting
- Gas cards
- Small and attractive assets
- Travel

- Financial condition
- General expenditures
- General revenue
- Open Public Meetings Act

RESULTS

In the areas we examined, the Authority's internal controls were adequate to safeguard public assets. The Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE AUTHORITY

The West Thurston Fire Authority provides emergency medical services and fire protection to the general public in Thurston County. The Authority was incorporated on January 1, 2010.

An elected, six-member Board of Commissioners governs the Authority. The Board appoints a Chief of Administration and a Chief of Operations to oversee the Authority's daily operations as well as its approximately 28 employees and 45 volunteer fire fighters. Supported primarily through property taxes, the Authority operated on a budget of approximately \$3.2 million for fiscal year 2013.
