ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Vashon Island School District No. 402 from September 1, 2011 through August 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Accounting/financial reporting
- Cash receipting
- Contracts/agreements
- Public works (high school modernization project)
- Financial condition

- Teacher education and experience (staff mix) reporting
- Student enrollment reporting
- Student transportation reporting
- Associated Student Body

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE DISTRICT

Vashon Island School District No. 402 serves approximately 1,554 students from kindergarten through 12th grade. The District is located west of Seattle on Vashon Island. The District operates one high school, one middle school and one elementary school.

An elected, five-member Board of Directors oversees the District. The Board appoints managers, approves budgets and handles other fiscal duties. For fiscal years 2012 and 2013, the District had operating budgets of approximately \$14.3 million and 14.2 million, respectively.

AUDIT HISTORY

We audit the District's financial statements and federal programs annually. We conduct an accountability audit every other year.

The 2009 audit found issues with internal controls over the preparation of financial statements, which resulted in a restatement. In addition, the 2009 audit had issues over both staff mix reporting and the use of restricted funds. The 2010 audit found a significant deficiency in preparation of the Child Nutrition Cluster grant reimbursements. All three of the prior audit findings have been resolved.
