ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Franklin County Fire Protection District No. 1 from January 1, 2010 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Accounting/financial reporting
- Open Public Meeting Act
- Procurement purchases
- Payroll
- Vehicle use

- Conflict of interest/ethics laws
- Payments/expenditures
- Compliance with grant requirements
- Annual report submission

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

Description of the District

ABOUT THE DISTRICT

Franklin County Fire Protection District No. 1 was established in 1947. An elected, three-member Board of Commissioners governs the District. Commissioners are elected to staggered, six-year terms. The District has approximately 35 volunteer firefighters.

The District provides fire protection and suppression services to the central part of Franklin County. In 2010 the city of Connell established an inter-local agreement with the District to ensure the city has an adequate response service for wild land/brush fires within the city limits.

Property taxes are the primary funding source for the District. The District's annual expenditures for 2010, 2011 and 2012 were approximately \$271,000, \$167,000 and \$137,000, respectively.
