AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Stevenson from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility billings/receivables
- Building permits
- Insurance
- Investments
- Payments/expenditures
- Open public meeting minutes
- Procurement
- Payroll/personnel

INFORMATION ABOUT THE CITY

The City of Stevenson was incorporated on December 2, 1907, and currently serves approximately 1,515 citizens in Skamania County. The City provides services including Municipal Court, fire protection, storm drainage, roads/sidewalk systems, water and sewer utilities, parks and recreation, planning and economic development, building inspection services and general administrative services.

An elected, five-member Council and Mayor govern the City. The Council appoints the City Administrator to oversee the City's daily operations as well as its nine employees. For 2013, the City operated on a budget of approximately \$6.5 million.
