## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Kent from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Citizen hotline referrals
- Self insurance programs (unemployment, worker's compensation, liability, health and welfare)
- General disbursements
- Procurement/bid law (public works projects, goods and services agreements)
- Payroll (vacation/sick leave cash outs, increase in payroll)

## RELATED REPORTS

### Financial

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements.

### Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report. That report includes federal findings regarding the following federal grant programs:

- Emergency Management Performance Grant, CFDA 97.042

The City did not have internal controls in place to ensure compliance with federal subrecipient monitoring requirements.

- Community Development Block Grant, CFDA 14.218

The City's internal controls were not adequate to ensure compliance with Community Development Block Grant Federal Funding Accountability and Transparency Act of 2006 (FFATA) reporting requirements.

## INFORMATION ABOUT THE CITY

The City of Kent was incorporated on May 28, 1890 in King County. The City operates under an elected council-mayor form of government. There are seven Council members. The Mayor is responsible for carrying out the policies and ordinances of the Council and overseeing the operations of the City and its 616 full-time employees.

The City serves approximately 120,500 residents and provides a full range of services to the public including general government, public safety, public works and leisure. The City is funded by a variety of revenue sources including property taxes, sales taxes, utility taxes, business taxes, charges for services and grants. In fiscal year 2013, the City's general fund operating budget was approximately \$73 million.
