## AUDIT SUMMARY

### Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated December 11, 2014, related to financial statement preparation. We appreciate the City's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of the City of Dayton from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Credit cards
- Procurement
- General disbursements
- Utility adjustments and billings
- Federal grants
- State grants

## INFORMATION ABOUT THE CITY

The City of Dayton was incorporated in 1882 and serves approximately 2,735 citizens. It is administered by a mayor-council form of government with seven elected Council Members and an independently elected Mayor. The City operates on an average annual budget of approximately \$4 million. Approximately 11 employees provide services including public safety, law enforcement, street improvement, economic development and recreation through its parks and swimming pool. The City also provides water and sewer services and operates a cemetery.
