## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Granite Falls Fire Department from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll
- Financial condition
- Reading program

## INFORMATION ABOUT THE DISTRICT

Snohomish County Fire Protection District No. 17, doing business as the Granite Falls Fire Department, provides fire prevention, suppression and emergency medical services to approximately 11,800 people living within the District's 38.5 square-mile boundary, which includes the city of Granite Falls.

The District is governed by a three-member Board of Commissioners, each of whom is elected to a six-year term. The Board appoints a Fire Chief to oversee the District's daily operations as well as its nine full-time employees and approximately 20 part-time employees. The District's operating expenditures totaled \$1,567,633, \$1,728,528 and \$1,740,864 in fiscal years 2011, 2012 and 2013, respectively.
