AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Issaquah from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting – Pickering Barn and Julius Boehm Swimming Pool
- Insurance/risk management – self insurance – unemployment compensation
- Interfund transactions/balances – cost allocation
- Third party cash receipting – courts

Our opinion on the City's financial statements is provided in a separate report, which includes the City's financial statements.

INFORMATION ABOUT THE CITY

The City of Issaquah serves over 32,000 citizens in east King County. The City provides services such as water, sewer, storm water, police, Municipal Court, cemetery, parks and recreation and development services.

The City has an elected Mayor as well as seven elected council members. The Mayor appoints, and council approves, the City Administrator who oversees the City's daily operations and employees. For fiscal year 2013, the City operated on an annual general fund budget of approximately \$34.1 million.
