AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the District. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Consolidated Irrigation District from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

INFORMATION ABOUT THE DISTRICT

Consolidated Irrigation District No. 14, doing business as Consolidate Irrigation District, provides water and irrigation services to residents of College Place and surrounding areas of Walla Walla County. An elected, three-member Board of Directors governs the District. The District has three part-time employees that aim to maintain and operate the District's water system and customers. The District operated on annual revenues of approximately \$230,000 in 2011 and 2012 and approximately \$310,000 in 2013.
