AUDIT SUMMARY

Results in brief

In the areas we audited, Housing Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Housing Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of HASCO from July 1, 2012 through June 30, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Housing Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Tenant rent payments

- Financial condition
- Procurement

Our opinion on the Housing Authority's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the Housing Authority's financial statements.

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Housing Authority's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report.

Special investigations

INFORMATION ABOUT THE HOUSING AUTHORITY

The Housing Authority of Snohomish County, doing business as HASCO, was incorporated in 1971 to provide low-income families and individuals with affordable and suitable housing within Snohomish County. The Housing Authority owns or manages about 2,100 units of housing and provides rental subsidies for over 3,300 additional families. In addition, the Housing Authority provides 208 housing units as general partner in two tax credit partnerships.

An appointed, six-member Board of Commissioners governs the Housing Authority. Board Members are appointed by the Snohomish County Executive and approved by the Snohomish County Council. The Board appoints an Executive Director to oversee the Housing Authority's daily operations as well as its 58 employees. For fiscal years 2013 and 2014, the Housing Authority's operating expenses totaled \$46,310,591 and \$46,996,243, respectively.
