AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated February 12, 2015, related to healthcare coverage for Commissioners. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of King County Drainage District No. 1 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement – public works projects
- General disbursements
- Small and attractive assets
- Health insurance coverage

INFORMATION ABOUT THE DISTRICT

King County Drainage District No. 1 was formed around 1905 to provide storm water drainage services to residents of the Green River Valley from approximately downtown Kent to south Renton. The District has one full-time and one part-time employee.

An elected, three-member Board of Commissioners governs the District. The District receives approximately \$400,000 in annual revenue.
