AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Lewis County Fire Protection District No. 5 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Key system controls:
 - Cash receipting
 - Payroll
 - Disbursements
- Open public meetings
- General disbursements

INFORMATION ABOUT THE DISTRICT

Lewis County Fire Protection District No. 5 was formed in 1955. The District provides fire prevention and suppression services, emergency medical aid and protection of life and property to residents living within Napavine and the surrounding area.

An elected, three-member Board of Commissioners governs the District and oversees roughly 25 volunteers and five full-time and one part-time District employees. The District operates on an annual budget of approximately \$650,000 for fire prevention and suppression services and \$100,000 for emergency medical services. Property taxes provide the primary source of revenue for the District.
