AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Onalaska School District No. 300 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- General revenues and expenditures
- Financial condition
- Enrollment
- Staff mix
- Significant accounting controls over: cash receipting, disbursements and payroll
- Procurement – public works
- Associated Student Body

INFORMATION ABOUT THE DISTRICT

Onalaska School District No. 300, located in Lewis County, provides public school service to approximately 714 students in kindergarten through 12th grade. The District provides basic education, supplemental programs and learning opportunities for students, such as special education, as well as food and transportation services.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to administer the District's day-to-day operations and carry out decisions made by the Board. The District employs 49 certificated and 51 classified employees. For the school year 2013-2014, the District operated on an annual budget of approximately \$7.8 million.
