AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated June 2, 2015, related to procurement requirements over purchases. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Columbia Water and Power Irrigation District from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billings/receivables
- Procurement purchases

- General disbursement
- Real estate purchase

INFORMATION ABOUT THE DISTRICT

The Columbia Water and Power Irrigation District was organized in December 1966 to serve Benton County. A three-member Board of Directors governs the District. The District has two employees who maintain and operate the District. The District has three customers, Ste. Michelle Wine Estates, Organic Farms and Glade Creek, and operates on an approximate \$2 million annual budget.
