AUDIT SUMMARY

Results in brief

In the areas we audited, Town operations complied with applicable requirements and provided adequate safeguarding of public resources. The Town also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Town of Creston from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Utility Billing

• Interfund transfers

• Cash Receipting

INFORMATION ABOUT THE TOWN

The Town of Creston serves 250 citizens in Lincoln County. The Town provides services including water, sewer, ambulance, fire, parks and recreation, streets, planning and economic development.

An elected, five-member Council and an independently elected Mayor govern the Town with two full-time employees. For fiscal year 2014, they had approximately \$1.1 million in expenditures.
