AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Methow Valley Communications District from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

INFORMATION ABOUT THE DISTRICT

The Methow Valley Communications District (formerly known as Okanogan Television Reception Districts No. 2 and No. 3) was established for purposes of constructing, maintaining and operating television translator stations. The District provides television and radio communications throughout the Methow Valley and Pateros as well as power for emergency and cellphone services on McClure Mountain.

The District is governed by a five-person volunteer Board of Directors who are appointed by the Okanogan County Commissioners. The District received annual revenue of \$306,600, \$69,921 and \$72,019 for fiscal years 2012, 2013 and 2014, respectively. The District's main source of revenue comes from assessments on properties within District boundaries.
