AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Greater Wenatchee Irrigation District from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Safeguarding of small and attractive assets
- General disbursements
- Controls over fuel purchasing

INFORMATION ABOUT THE DISTRICT

The Greater Wenatchee Irrigation District was incorporated in 1973 when it separated from the U.S. Bureau of Reclamation. The Bureau has regulatory oversight of the District, under federal law. The District provides irrigation water from the Columbia River to commercial, agricultural and residential users.

The District operates three units, one in Chelan County and two in Douglas County, and has eight full-time employees. The District's five-member Board of Directors is responsible for oversight of the District. The District operates on an approximate \$2 million annual budget. Douglas County is the ex-officio treasurer for the District.
