## AUDIT SUMMARY

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of East Pierce Fire & Rescue from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Pharmaceutical inventory
- Payments to Commissioners and volunteers
- Safeguarding of small and attractive assets
- Controls over key software applications

### INFORMATION ABOUT THE DISTRICT

Formerly Pierce County Fire Protection District No, 22, East Pierce Fire & Rescue was created when the City of Bonney Lake Fire Department, Lake Tapps Fire and Pierce County Fire Protection District No. 24 merged in 2000 to provide 24-hour emergency medical and fire suppression services. Since then, other towns and fire protection districts have merged with the District, including Pierce County Fire Protection District Nos. 1 and 12, South Prairie Fire District No. 20 and the cities of Sumner, Milton and Edgewood.

Today, the District serves a population of 88,200 citizens living in and around Bonney Lake, Sumner, Lake Tapps, Edgewood, Milton, South Prairie and the Ridge communities. The District covers approximately 151 square miles and protects residents from 12 stations, six staffed and four volunteer, a logistics warehouse and one water rescue facility.

All full-time firefighters are cross-trained as either emergency medical technicians (EMTs) or paramedics and are able to respond to both medical emergencies and fires. The District's 63 career firefighter-EMTs, 44 career firefighter-paramedics, 27 volunteer firefighters and 15 other command staff members and administrative staff are divided into eight divisions. These divisions include Operations, Emergency Medical Services, Volunteer, Training, Fire Prevention, Safety, Emergency Management and Budget and Finance.

An independently elected, seven-member Board of Citizens, called Fire Commissioners, governs the District. Voters approved a measure to maintain a seven-member Board in fiscal year 2014. For fiscal year 2014, the District operated on a budget of approximately \$29.7 million for the general fund.
