## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of White Salmon Valley School District No. 405-17 from September 1, 2013 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting food services
- Open public meeting minutes
- Financial condition
- Payments/expenditures

- Teacher education and experience (staff mix) reporting
- Student enrollment reporting

## INFORMATION ABOUT THE DISTRICT

The White Salmon School District serves approximately 1,261 students in Klickitat County. The District provides the full range of school programs and services including basic elementary, intermediate, middle school, high school, Running Start, Special Education and an alternative high school program. The District provides pupil transportation, school breakfast and lunch and numerous programs for remedial and enriched education.

The District is administered by a five-member Board of Directors and operates on an annual budget of approximately \$14 million. Students are served at three buildings by more than 180 full- and part-time employees.
