## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Chelan County Fire Protection District No. 3 from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Open public meeting minutes
- General disbursements
- Credit cards
- Small and attractive assets

## INFORMATION ABOUT THE DISTRICT

Chelan County Fire Protection District No. 3, established in 1947, provides fire prevention and suppression services, emergency medical aid, and protection of life and property. The District's service area covers residents in Chelan County in the Leavenworth area.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as its 4 employees and 19 volunteers. For the fiscal years 2013, 2014, and 2015 the District operated on annual revenues of approximately \$490,000, \$649,000, and \$511,000, respectively. Chelan County serves as the ex-officio Treasurer for the District.
