AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated March 21, 2016, related to Career and Technical Education apportionment. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Chewelah School District No. 36 from September 1, 2014 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Insurance/risk management
- Apportionment Career and Technical Education
- Special education reporting
- Payroll/personnel

INFORMATION ABOUT THE DISTRICT

Chewelah School District No. 36 serves approximately 830 students in kindergarten through 12th grade in Stevens County. The District has one elementary school, one combined junior/senior high school and two alternative education programs.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent, who is responsible for the day-to-day operations as well as approximately 115 employees. For fiscal year 2015, the District operated on an annual general fund budget of approximately \$9.3 million.
