AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated April 13, 2016, related to utility cash receipting controls. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Fall City Water District from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility cash receipting
- Contracts and agreements

INFORMATION ABOUT THE DISTRICT

Fall City Water District, formerly known as King County Water District No. 127, was formed in 1982 to operate a well-water distribution system in the Fall City area of King County. The District began with two wells, and now operates seven that serve approximately 1,079 customers.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Manager to oversee the District's daily operations as well as its three full-time employees. For the years under audit, the District had an annual operating budget of approximately \$491,546 in 2012, \$506,799 in 2013 and \$637,996 in 2014.
