## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, during the audit certain matters came to our attention that are currently under investigation.

### About the audit

This report contains the results of our independent accountability audit of Kennewick Public Hospital District No. 1 from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Patient billings
- Contracts/agreements
- Debt/covenants
- Financial condition
- Payments/expenditures
- Advertising/sponsorship
- Gifts of public funds
- Payroll/personnel

## RELATED REPORTS

### **Financial**

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from the Eide Bailly LLP. The firm reported a material weakness in internal controls over financial reporting regarding preparation of financial reporting, audit adjustments, account reconciliations and manual journal entries.

## INFORMATION ABOUT THE DISTRICT

Kennewick Public Hospital District No. 1, doing business as Trios Health (formerly Kennewick General Hospital) provides health care services to patients in Benton and Franklin counties. Services include acute care, emergency room, home health, outpatient surgery and related services such as laboratory and X-ray. The District operates two Hospital locations, Southridge Campus and Auburn Campus Birthing Center. The District also owns and operates Trios Health Physician Clinics, formerly Northwest Practice Management, composed of several clinics and medical practices for which it provides management services. In addition, the District owns and operates Benton Franklin Elder Services, doing business as Adult Day Services of the Tri-Cities.

An elected, seven-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 915 full- and part-time employees. For fiscal year 2014, the District operated on an annual budget of \$155 million.
