AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated June 7, 2016, related to controls over credit card disbursements and payroll. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Point Roberts Water District No. 4 from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll
- Disbursements
- Financial condition
- Interfund loan
- Cash receipting and customer adjustment follow up

INFORMATION ABOUT THE DISTRICT

Point Roberts Water District No. 4 was formed in 1956 to provide water services to residents of Point Roberts in Whatcom County. The District serves approximately 2,300 water customers and 80 sewer customers.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Manager to oversee the District's daily operations as well as its three employees. For fiscal years 2013, 2014 and 2015, the District generated revenue of approximately \$1,238,000, \$1,376,000 and \$1,603,000, respectively.
