## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Longview from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Building permits and cash receipting
- Equipment rental and replacement billings
- Self-insurance programs – workers compensation and unemployment
- General disbursements
- Payroll
- Police Department – cash receipting, petty cash, property room and seizures
- Open public meeting minutes
- Citizen concern

## INFORMATION ABOUT THE CITY

The City of Longview, incorporated in 1924, is the largest city in Cowlitz County and it serves approximately 37,000 citizens. The City provides services including police, fire, water, sewer, garbage collection, parks and recreation, planning and building, library and general administrative services.

An elected, seven-member council governs the City. The Council appoints a city manager to oversee the City's daily operations. For the current 2015-2016 biennium, the City is operating on a biennial budget of \$207.9 million.
