AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Dayton School District No. 2 from September 1, 2014 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Career and technical education
- Insurance/risk management
- Credit cards
- Teacher education and experience (staff mix) reporting
- Financial condition

INFORMATION ABOUT THE DISTRICT

Dayton School District No. 2 is located in Columbia County in southeastern Washington at the base of the Blue Mountains. The District provides educational services to approximately 400 students. It operates one high school, a middle school, an elementary school and a preschool.

An elected, five-member Board of Directors has oversight responsibility for the District and appoints a Superintendent who is responsible for the daily operations. The District has approximately 90 employees and an annual operating budget of approximately \$6 million.
