## AUDIT SUMMARY

### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated November 7, 2016, related to procurement. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of the Skyline Hospital from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Foundation agreement
- Cash receipting
- General disbursements
- Pharmaceutical inventory
- Payroll and benefits
- Procurement of public works
- Financial condition
- Self-insured health and welfare

### **Financial**

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Skyline Hospital.

## INFORMATION ABOUT THE DISTRICT

Klickitat County Public Hospital District No. 2, doing business as Skyline Hospital, owns and operates a 32-bed acute care facility in Klickitat County. The District offers surgery, cardiopulmonary, radiology, laboratory, physical therapy, pharmacy and emergency services. In addition, the District operates a Skilled Nursing Facility (Swing Bed) to provide temporary transitional needs for patients that need extended care. The District provides additional services for the community through its specialty clinics and visiting physicians. These services include cardiology, neurology, podiatry and orthopedics.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 120 full-time employees. For 2014 and 2015, the District operated on an annual budget of approximately \$15.4 and \$16.2 million in net operating revenue, respectively.
