#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Northeast Sammamish Sewer and Water District from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (bidding/prevailing wage)
- Financial condition

- Credit card payments
- Petty cash disbursements

### **INFORMATION ABOUT THE DISTRICT**

The Northeast Sammamish Sewer and Water District is a municipal corporation, which was created as the Sahalee Sewer District in 1969. The District first constructed sanitary sewer facilities in the Sahalee area in the early 1970s as part of the Sahalee Estates development. When the Sahalee Sewer District expanded to serve additional developments, the District's name was changed to represent the actual service area, which covers 7,800 acres. The District is located within the City of Sammamish in King County and provides water service to approximately 3,290 customer accounts and sewer service to approximately 4,805 customer accounts.

An elected, three-member Board of Commissioners governs the District. The Board appoints a General Manager to oversee the District's daily operations as well as its seven additional employees. For fiscal year 2015, the District had operating revenue of approximately \$6 million and operating expenses of \$5.5 million.
