## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Benton Conservation District from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Credit card disbursements
- Payroll disbursements
- General disbursements
- Cost share agreements

## INFORMATION ABOUT THE DISTRICT

The Benton Conservation District was organized in 1942 to develop and administer voluntary, non-regulatory programs for the use and conservation of natural resources in Benton County.

The District is governed by a Board of volunteer Supervisors that establishes priorities and sets policies. Three supervisors are locally elected, and at least two of the three elected supervisors must be landowners or operators of a farm. Two supervisors are appointed by the Washington State Conservation Commission, and at least one must be a landowner or operate a farm. District Supervisors direct the expertise of the District working in partnership with the federal Natural Resources Conservation Services. The District operates on local, state and federal grants and contracts to perform projects, usually with some form of local matching funds. In 2015, the District's revenues were approximately \$525,000 and expenditures were approximately \$510,000.
