AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Island Hospital from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements
- Contracts
- Financial condition
- Open Public Meetings Act
- Self-insurance
- Small and attractive items prior year issue follow-up

INFORMATION ABOUT THE DISTRICT

Skagit County Public Hospital District No. 2, doing business as Island Hospital, was established in 1962 and is located in the city of Anacortes. The District offers a full range of comprehensive medical services and support programs for healthcare needs to citizens in western Skagit County, North Whidbey Island, and the San Juan Islands. The District is licensed for 43 in-patient beds and provides additional outpatient, home health care, and cancer care services. The District operates four family practice clinics and seven specialty clinics located in Anacortes and on Lopez and Orcas Islands.

An elected five-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 750 employees. For fiscal year 2015, the District operated on \$92.4 million in expenses.
