AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated December 12, 2016, related to small and attractive assets. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Lynnwood from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Safeguarding of assets
- Payroll system review
- Cash receipting system review
- Police Department system review
- Self insurance
- Emergency Medical Services billings
- Information systems disaster recovery

Financial

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements. That report is available on our website, http://portal.sao.wa.gov/ReportSearch.

That report includes a finding for a significant deficiency in internal controls over financial reporting regarding the City's internal controls over accounting and financial reporting.

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. INFORMATION ABOUT THE CITY

The City of Lynnwood has a population of 36,420 citizens and encompasses more than seven square miles in Snohomish County. The City provides services including police, fire protection, emergency medical services, water distribution, sewage collection and treatment, street construction and maintenance, parks and recreational facilities including a pool, a senior center and a golf course. In addition, the City has a Municipal Court and a jail.

An elected, seven-member Council and a separately elected Mayor govern the City. Council Members serve staggered, four-year terms. The Council appoints management to oversee the City's daily operations as well as its approximately 373 full-time employees and 130 part-time employees. For the 2015-2016 biennium, the City operated on a budget totaling \$197.5 million.
