AUDIT SUMMARY

Results in brief

In the areas we audited, University operations complied with applicable requirements and provided adequate safeguarding of public resources. The University also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Western Washington University from July 1, 2014 through June 30, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the University's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Disbursement processes, including travel, credit cards and employee reimbursements
- Third party cash receipting follow-up
- Parking services

Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Comprehensive Annual Financial Report (CAFR) prepared by and available from the Office of Financial Management.

The CAFR reflects the financial activities of all funds, organizations, institutions, agencies, departments and offices that are part of the state's reporting entity. That report is issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

INFORMATION ABOUT THE UNIVERSITY

Western Washington University, formerly Western Washington State College, achieved university status in 1977. Located in the city of Bellingham, the University serves approximately 15,000 students each quarter with approximately 1,695 permanent employees.

An eight-member Board of Trustees, appointed by the Governor and confirmed by the Senate, is responsible for oversight of University operations. Dr. Sabah Randhawa became the University's 14th President on August 1, 2016. The University's operating budget for the 2014-2015 and 2015-2016 fiscal years were \$145 and \$152.4 million, respectively. The major sources of revenue for the University include student tuition and fees, as well as state appropriations.
