AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated December 13, 2016, related to operational controls and compliance. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Aeneas Lake Irrigation District from January 1, 2013 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• General disbursements and related compliance

INFORMATION ABOUT THE DISTRICT

The Aeneas Lake Irrigation District provides irrigation to an area west of Tonasket, located in Okanogan County. The District supplies water to more than 1,300 acres.

The five-member Board governs the District. The District has one seasonal employee who monitors the District's water lines and ponds while providing minor repair and maintenance. All major repair and maintenance projects are contracted out. District revenues were \$217,000, \$236,000, and \$331,000 for the 2013 through 2015 years, respectively.
