AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated February 21, 2017, related to the safeguarding of small and attractive assets. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Duvall from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Credit card transactions
- Payroll
- Small and attractive assets
- Disbursements with SnoValley Senior Center
- Disbursements: approval of vouchers and claim checks

INFORMATION ABOUT THE CITY

The City of Duvall is located in northern King County and serves approximately 7,325 citizens. The City provides an array of services including public works, a planning and building department, and a water and sewer utility.

An elected, seven-member Council and an independently elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its approximately 41 employees. For fiscal year 2014 and 2015, the City operated on an annual budget of \$23.4 million and \$24.2 million, respectively.
