AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Clover Park School District No. 400 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body
- Safeguarding of small and attractive assets such as computers
- Procurement
- Payroll leave cashouts
- Credit card and general disbursements

INFORMATION ABOUT THE DISTRICT

Clover Park School District No. 400 provides educational services to approximately 12,400 students in Pierce County. The District operates two high schools, one alternative high school, four middle schools, 17 elementary schools and various special education programs.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 1,400 employees. The District operates on an annual budget of approximately \$162 million.
