AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Richland School District No. 400 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body (ASB) school store
- IT security backup and recovery for critical systems and data
- Surplus property safeguarding and • disposal process • Third party cash receipting
- Valid vendors/disbursements

Payroll/personnel – salaries

INFORMATION ABOUT THE DISTRICT

Richland School District No. 400 provides educational services to approximately 12,250 students in kindergarten through 12th grade in Benton County. The District encompasses approximately 504 square miles including the cities of Richland, West Richland and a portion of the City of Kennewick. The District operates nine elementary schools, three middle schools and three high schools, including one alternative high school.

An elected, five-member Board of Directors governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 1,650 employees. For fiscal year 2016, the District reported approximately \$179 million in operating expenditures.
