AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Waitsburg School District No. 401-100 from September 1, 2013 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Career and Technical education (CTE) program compliance
- Credit card policy and expenditures
- Self-insurance

- Payroll expenditures
- Associated Student Body cash deposits and reconciliations

INFORMATION ABOUT THE DISTRICT

The Waitsburg School District No. 401-100 is a small rural kindergarten through 12th grade district in Walla Walla County. The District has approximately 275 students and employs a staff of approximately 22 certified and 20 classified employees.

An elected, five-member Board of Directors governs the District and appoints a Superintendent, who is responsible for the day-to-day operations. The District had annual revenues and expenditures of \$4,093,439 and \$4,039,499, \$4,231,194 and \$4,158,914, and \$4,529,823 and \$4,575,609, for fiscal years 2014, 2015 and 2016 respectively.
