AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Prosser School District No. 116 from September 1, 2013 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance
- Transportation
- Career and Technical Education (CTE) review of certifications, courses, and classifications
- Payroll disbursements

- Associated Student Body (ASB) expenditures
- IT security of new and current systems
- Small & attractive asset tracking and monitoring

INFORMATION ABOUT THE DISTRICT

Prosser School District No. 116 provides educational services to approximately 2,800 students in kindergarten through 12th grade in Benton County. It operates one high school, one alternative school, a middle school and three elementary schools.

An elected, five-member Board of Directors administers the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 316 employees. The District had total revenue of approximately \$29.9 million, \$31.1 million and \$33.2 million in fiscal years 2014, 2015 and 2016, respectively.
