AUDIT SUMMARY

Results in brief

In the areas we audited, Port operations complied with applicable requirements and provided adequate safeguarding of public resources. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Port of Bellingham from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement
- Self-insurance

- Marinas and moorage
- Contracts and agreements

INFORMATION ABOUT THE PORT

The Port of Bellingham, located in Whatcom County, provides an array of services including aviation, marinas, marine terminals and property management.

An elected, three-member Board of Commissioners governs the Port. The Board sets policies and appoints the Executive Director to oversee the Port's daily operations as well as approximately 100 regular and up to 25 seasonal employees. In fiscal year 2016, the Port had operating expenses of approximately \$30 million.
