## AUDIT SUMMARY

### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated July 17, 2017, related to asset management and Associated Student Body activities addressed in the management letter. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of Seattle School District No. 1 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Student transportation reporting
- Procurement of public works projects
- Asset management
- Associated Student Body

## INFORMATION ABOUT THE DISTRICT

Seattle School District No. 1 serves more than 52,000 students and operates 10 high schools, 10 middle schools, 59 elementary schools, 11 kindergarten through eighth grade schools (K-8), and six alternative schools and special programs.

District activities are monitored by an elected, seven-member Board of Directors. The Board oversees the governance of the District and appoints a Superintendent to oversee the District's operations. The District had a General Fund budget of \$710.6 million for the 2015-2016 school year.
