### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Naches Park and Recreation District from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Cash receipting
- Open public meeting minutes
- Payroll

- Disbursements
- Credit card use
- Petty cash activity
- Employee reimbursements

## INFORMATION ABOUT THE DISTRICT

The Naches Park and Recreation District operates a public swimming pool and a park. The District is primarily supported through property taxes and operates with annual revenue of approximately \$194,000.

The District is administered by an elected, five-member Board of Commissioners and has one part-time employee and approximately 10 to 15 seasonal employees.
