AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Snohomish County Diking District No. 5 from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- General disbursement system review
- Compliance with the Open Public Meetings Act

INFORMATION ABOUT THE DISTRICT

Snohomish County Diking District No. 5 provides maintenance of a flood control, diking system around Smith Island near Everett.

An elected, three-member Board of Commissioners governs the District. The District received annual revenues of approximately \$400,000, \$700,000, and \$790,000 in fiscal years 2014, 2015, and 2016, respectively.
