AUDIT SUMMARY

Results in brief

In the areas we audited, Town operations complied with applicable requirements and provided adequate safeguarding of public resources. The Town also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Town of Ione from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Insurance/risk management
- Cash receipting
- Payments/expenditures

INFORMATION ABOUT THE TOWN

The Town of Ione, located in Pend Oreille County, has a population of approximately 425 citizens.

It is administered by a mayor-council form of government with five elected Council Members and an independently elected Mayor. The Town operated on a budget of \$1.3 million for 2014, \$1.2 million in 2015 and \$1 million in 2016. Its six employees provide services including general administration, fire protection administration, water, sewer, airport, street improvements, planning and economic development. The Town also provides public safety through a contractual agreement with Pend Oreille County.
