AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Kittitas Valley Healthcare from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Cash receipting – Family Medicine (Ellensburg)
- Disbursements
- Credit card usage
- Information Systems department inventory
- Contract compliance
- Cell Phone vouchers
- Third Party cash receipting

Financial

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Kittitas County Hospital District No. 1.

INFORMATION ABOUT THE DISTRICT

Kittitas County Public Hospital District No. 1, doing business as Kittitas Valley Healthcare, owns and operates a 25-bed acute care hospital in Ellensburg. Services offered by the District include medical, surgical, labor-delivery care, 24-hour emergency care, physical rehabilitation, home health, and radiology services. The District also operates KVH Orthopedics, KVH Family Medicine-Cle Elum, KVH Family Medicine-Ellensburg, KVH Women's Health, KVH Internal Medicine, KVH General Surgery, and KVH Hospice.

An elected, five-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its 500 employees. For fiscal year 2016, the District operated on an annual budget of approximately \$60 million.
