AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated January 19, 2018, related to cost allocations to restricted funds. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Waitsburg from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Payroll payments for employees with high increases
- Procurement for architecture and engineering contracts
- Procurement for the Main Street public works project
- Cash receipting at City Hall and through online system
- Valid vendors and general disbursements

- Compliance with third party receipting requirements for the online payment system
- Compliance with cost allocation plan for inter-fund charges
- Unemployment self-insurance
- Accounting system conversion process and access levels
- Billing rate changes and billing process

INFORMATION ABOUT THE CITY

The City of Waitsburg, located in Walla Walla County, was incorporated in 1865 and currently serves 1,200 citizens.

It operates under a council-mayor form of government with a five-member Council and Mayor. The City has six full-time employees who provide services including fire prevention, parks and recreation, street maintenance and repair, water and sewer utilities, a cemetery, fairgrounds and a library along with other administrative functions. For fiscal years 2014, 2015 and 2016, the City's annual revenues for all funds were approximately \$2.7 million, \$1.4 million and \$1.5 million for each year, respectively.
