#### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Samaritan Healthcare from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Internal countrols over investment activity and compliance with qualified public depository requirements
- Human Resources Department employee recognition purchases and awards
- Procurement of public works projects
- District-wide controls over petty cash and change funds

#### INFORMATION ABOUT THE DISTRICT

Grant County Public Hospital District No. 1, doing business as Samaritan Healthcare, operates a licensed 50-bed acute care hospital in Moses Lake. The District also operates a rural health clinic and leases space to other health-care organizations and professionals in Grant County.

An elected, five-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its approximately 600 employees. During the 2016 fiscal year the District's operating revenues and expenses were approximately \$75 million and \$71 million, respectively.
